Associate Purchase Program Form

- **Step 1:** Make sure you are eligible to participate (see "Eligibility" below).
- **Step 2:** Associate/eligible family member visits a Honda/Acura Dealership and advises the <u>Sales Manager</u> that they are eligible to participate in the Associate Purchase Program.
- **Step 3:** The Associate/eligible family member asks the <u>Sales Manager</u> if they have the product and if they are willing to sell it to them through the Program. (Dealerships are not obligated to participate in the Associate Purchase Program.)
- **Step 4:** If the Dealership has the product and agrees to participate in the Program, the Associate completes an "Associate Purchase Program Form" (available in Associate Services or at www.hcminfo.ca) and places it in the Drop Box in Associate Services.
- **Step 5:** HCM Associate Services processes the Form and sends it to Honda Canada Inc. (CH). CH will e-mail a Letter of Introduction (LOI) to the Associate & Dealership within five business days.
- **Step 6:** Upon receiving the LOI, the Dealership will contact the eligible buyer to complete the purchase. (If the Dealership has not contacted the eligible buyer by the 5th business day, the eligible buyer can contact the Dealership.)

ASSOCIATE REBATE: If the purchase is eligible for an Associate Rebate (see eligibility below), it will be indicated on the Letter of Introduction (LOI) and the Dealership will deduct it from the Associate Price of the vehicle at the time of purchase.

HAVP BUYOUT vehicles are not counted towards purchase program limits.
